Bridal Contract Terms:

BOOKINGS: To secure a date and scheduled makeup times a signed contract is required with a \$140 deposit due at the time of signing. The deposit is deducted from the total price of the package - it is not an additional charge. On the wedding day, the hair will be done following a schedule. Every person getting their hair done in an updo, half-up style, or curls must have their hair already **Washed/Dry**. The stylist will not allow time for this. If such a case arises, the stylist will charge extra to blow dry (if time permits) The Bride must confirm and commit to the number of services stated above. Charges will include all people stated above. In the event that the contracted Makeup Artist is unable to perform the services agreed upon due to an emergency, illness, or unexpected occurrence a trusted substitute Makeup Artist/ Hair stylist will be assigned and informed of the contracted and discussed arrangements.



We do not accept last minute services on the day of the event. Please make every person that needs service is listed on the contract. We need a certain amount of time per person to give quality service.

DELAYS: A late fee of \$25.00 will be charged for every 30 minutes of delay when a client is late for a scheduled time or if scheduled makeup exceeds allotted time because of client delays.

PARKING : we offer free parking in front of the salon or street parking.

LIABILITY: All brushes and makeup products are kept sanitary. All products are sanitized between every makeup application. Any skin conditions or sensitivities of the client(s) should be reported by the makeup artist prior to application, and if needed a sample test of makeup may be performed on skin.

CANCELLATION POLICY: Cancellation must be made 30 days prior to your reserved date - if a cancellation notice is given in accordance with the 30 day policy , the deposit will be refunded in entirety. However, in the event of a late cancellation, the deposit is non-refundable.

WE HAVE THE RIGHT TO REFUSE SERVICE TO ANYONE: If our makeup artist(s) or hairstylists feel uncomfortable, threatened or verbally abused in any way, she will have the right to leave the premises without completing services.

PAYMENT: The final balance is due on the day of the event prior to services. Cash and credit are accepted, with the exception of American Express cards. Bride is responsible for balances from any members of the party listed above who fail to provide payment.

FEE DETAILS

Trial run: A trial run is recommended for the bride. This needs to be booked at least 30 days prior to the wedding day .The day of your trial run you will be charged for hair 35 + and makeup 35 + **Total= 70+** (upon consultation) for not longer than 90 minutes.

Wedding Day:

*Bridal package hair and makeup : **\$90 Per hour**

Bride only makeup: **\$70 Per hour**

Bride only hair : **\$100+**

*Bridesmaid package hair and makeup : **\$120+**

Bridesmaid only make up : **\$ 70+**

Bridesmaid only hair : **\$ 70+**

*Jr. Bridesmaid package hair and makeup: **\$ 50+**

Jr.Bridesmaid only makeup :**\$25+**

Jr Bridesmaid only hair : **\$30+**

*Every Wash and Blowdry will be same price as the salon list price: **\$ 35+**
